**Dear Mr. Frazer:**

I am writing to you upon the advice of my attorney.

You are well aware that you are a Foundation legal counsel, not an attorney to any individual or subgroup of Trustees. Any legal advice concerning Foundation and Trustee matters that you have given to any Trustee and the Foundation staff, including the Executive Director, should also be made available to me.

I am asking you to send copies of any and all letters, e-mails, and fax messages to any Trustees and the content of any telephone, in person, written, or other type of conversations you have had with any Trustee regarding Foundation and Trustee matters. The contents of these conversations can be summarized.

I have been advised that it is my right to request and receive this information, and that five Trustees jointly share the fiduciary duty. My request for legal advice you have given and these conversations is specifically for the period starting September 1999 to the present and onward.

(i) Please send me by e-mail all e-mails you have received from any Trustee or staff, and all e-mails you sent to any Trustee or to the staff of Urantia Foundation for the period noted above. My e-mail address is: [kchoi@iastate.edu](mailto:kchoi@iastate.edu).

(ii) Please send me copies of any fax messages you received from a Trustee or Foundation and any fax messages you have sent to any Trustee or staff of the Foundation for the period
